**1. ELIGIBILITY.** The “Xcel Energy and Denver Broncos Just Like Miles Sweepstakes” (the “Just Like Miles Sweepstakes” or the “Sweepstakes”), sponsored by Public Service Company of Colorado d/b/a Xcel Energy (“Xcel Energy”) and the Denver Broncos (collectively, Xcel Energy and Denver Broncos are (“Sponsors”)), is open only to entrants who, as of the entry date, are legal residents of the State of Colorado (“Territory”) who are at least eighteen (18) years old. The Sweepstakes is void outside the Territory and where prohibited by law. Employees, officers, directors, members, managers, representatives, and agents of Sponsors, the National Football League (“NFL”), Facebook, and their respective parents, subsidiaries, affiliates, divisions, advertising and promotion agencies (collectively, the “Released Parties”) and the immediate families (defined as parents, spouses, domestic partners, in-laws, children, siblings, grandparents, grandchildren, and their respective spouses) or members of the same household (whether related or not) of each such individual are not eligible to enter. Corporate entities are not eligible and have no right to claim any prize won by their employees.

**2. TIMING.** The Sweepstakes begins at 10:00:00 AM Mountain Time (“MT”) on Monday, October 28, 2019 and ends at 11:59:59 PM MT on Sunday, December 15, 2019 (the “Entry Period”).

**3. HOW TO ENTER.** There is one way to enter the Sweepstakes: during the Entry Period, eligible individuals may enter the Sweepstakes by clicking on the Just Like Miles Sweepstakes Facebook posts made by the Denver Broncos, which will feature an energy efficiency video. Follow the onscreen links and instructions to provide contact information, agree to the Official Rules and submit an entry. Entrants will also have the opportunity to answer a few optional energy efficiency and Denver Broncos questions. Completing the questions provided is **not** required for entry.

There will be four (4) different energy efficiency posts during the Entry Period. You may submit an entry through one (1), some, or all four (4) of the different energy efficiency posts. Entry for one post will not automatically “rollover” to any subsequent post if the entrant is not a sweepstakes winner of the post entered by. **Limit of one entry per post, for a total of four (4) online entries** in this Sweepstakes, per person, per Facebook account, during the entry period. Additional entries beyond the specified limit will be void.

Each of the Just Like Miles Sweepstakes Facebook posts will be posted and entries for those posts must be submitted during the following periods:

- **Period 1** – Post #1 will be posted on October 28, 2019 at or around 9:00:00AM, with entries accepted for Post #1 from its posting until November 3, 2019 at 11:59:59 PM
- **Period 2** – Post #2 will be posted on November 11, 2019 at or around 9:00:00AM, with entries accepted for Post #2 from its posting until November 17, 2019 at 11:59:59 PM
- **Period 3** – Post #3 will be posted on November 25, 2019 at or around 9:00:00AM, with entries accepted for Post #3 from its posting until December 1, 2019 at 11:59:59 PM
- **Period 4** – Post #4 will be posted on December 9, 2019 at or around 9:00AM, with entries accepted for Post #4 from its posting until December 15, 2019 at 11:59:59 PM

You must be a registered member of Facebook and in compliance with the Facebook Terms located at <http://www.facebook.com/home.php#!/terms.php> to enter. Membership on Facebook is free, and can be obtained by visiting [www.facebook.com](http://www.facebook.com) and following the onscreen instructions to register for and open an account. Anyone found to have used multiple Facebook accounts to enter will be ineligible.

**LIMIT:** One (1) entry per person for each of the four (4) different energy efficiency Facebook posts posted by the Denver Broncos during the Entry Period, for a total of four (4) entries per Facebook account, and per address (physical or email) in the Sweepstakes. Entries may not be acknowledged and will not be returned. Only entries actually received by the Denver Broncos in accordance with the deadlines set forth above will be considered in this Sweepstakes; other proof of submission will not be deemed to be proof of receipt of entry by the Denver Broncos. Any attempt made to submit entries in excess of any stated limit or otherwise in violation of these Official Rules (including by using multiple or false contact information or otherwise) may be disqualified. The Denver Broncos’s clock will be the official timekeeper for this Sweepstakes. Entries that are (i) forged, altered, incomplete, lost, late, illegible, unintelligible, duplicated, misdirected, mutilated, illegitimate, garbled or postage-due; (ii) generated by a macro, bot, or other automated means; or (iii) submitted with intent to subvert the entry process will not be accepted and are void. Those who do not provide the required information or abide by these Official Rules and other instructions of the Denver Broncos and its representatives may, in the Denver Broncos’ sole discretion, be disqualified and any associated entry void. Entries or participation made on behalf of any other individual or any entity or group, or originating at any online service other than those described above (including, without limitation, through commercial promotion subscription, notification, or entering services) will be declared invalid and disqualified for this Sweepstakes. In the event of a dispute as to the identity of an entrant, the authorized account holder of the email address submitted with the disputed entry will be deemed to be the entrant, but only if that person satisfies the eligibility requirements, otherwise the entry will be disqualified. Potential winners

may be required to show proof of being the authorized account holder. The “authorized account holder” is the natural person assigned to an email address by an online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted email address (e.g., an educational institution, business, or ISP). If a dispute regarding the identity of an entrant cannot be resolved to Sponsors’ satisfaction, the entry will be deemed ineligible. As a condition of entering the Sweepstakes, each entrant gives consent for Sponsors to obtain and deliver his or her name, address and other information to third parties for the purpose of administering this Sweepstakes and complying with applicable laws, regulations, and rules.

**4. AGREEMENT TO OFFICIAL RULES AND DECISIONS.** By participating in the Sweepstakes, each entrant fully and unconditionally agrees to be bound by and accepts these Official Rules and the decisions of Sponsors (including, without limitation, interpretation of these Official Rules, decisions regarding eligibility of entries, the selection of the winners, and the awarding of the prizes), which are final and binding in all respects.

**5. DRAWING; ODDS; NOTIFICATION.** On or before the following dates, Sponsors or their designated representatives (whose decisions regarding the random drawing will be final) will randomly select one (1) potential winner from among all eligible entries received by the Denver Broncos for each designated period, for a total of four (4) potential winners:

- **Period 1** – November 4, 2019 at or around 12:00PM
- **Period 2** – November 18, 2019 at or around 12:00PM
- **Period 3** – December 2, 2019 at or around 12:00PM
- **Period 4** – December 16, 2019 at or around 12:00PM

Odds of winning a prize depend on the number of eligible entries received by the Denver Broncos in the Sweepstakes. Potential winners will be notified by phone, mail, Facebook message, and/or email (as determined by the Denver Broncos in its sole discretion) within approximately 1 hour after the winner selection. Potential winners may be required to execute, have notarized (if applicable), and return to the Denver Broncos an Affidavit of Eligibility, a Liability Release, and, except where prohibited by law, a Publicity Release, as well as tax documents (collectively, the “**Prize Winner Documents**”) (any or all of which may require the winner to provide his or her Social Security Number), without alteration and in the form provided by the Denver Broncos in order to claim his/her prize. The Prize Winner Documents must be returned to the Denver Broncos by the date and/or time indicated within the Prize Winner Documents and are subject to verification. If (i) the potential winner cannot be contacted or does not respond as instructed within twelve (24) hours of the first attempt to contact him/her, (ii) the potential winner fails to return the Prize Winner Documents within the specified time, (iii) any prize or prize notification is returned as undeliverable, (iv) the potential winner is found to be ineligible, or (v) the potential winner does not comply with the Official Rules, then the potential winner may, in Sponsors’ sole discretion, be disqualified and an alternate winner selected by the Denver Broncos. The Denver Broncos reserve the right to modify the notification procedures in connection with the selection of any alternate potential winner, if any. The prizes, if legitimately claimed, will be awarded. Sponsors will not be obligated to pursue more than three (3) alternate winners (time permitting) for any prize for any reason, after which that prize may go unawarded.

6. **PRIZE.** Four (4) winners, subject to verification, will *each* receive one prize. The prize awarded per post will consist solely of the following:

- Post #1: One (1) autographed jersey (Player TBD)
- Post #2: Two (2) upper level game tickets to the Denver Broncos vs. Los Angeles Chargers game on 12/1
- Post #3: One (1) autographed football (Player TBD)
- Post #4: One (1) autographed photograph (Player TBD)

The approximate retail value (“ARV”) of each prize is listed in the following table:

The total ARV of all prizes to be awarded in this Sweepstakes is \$560 USD.

Tickets for the winner of Post #2 are subject to additional terms, conditions, and restrictions imposed by their issuer. Prize details not specified in these Official Rules (included seat location at the Event) will be determined by Denver Broncos in its sole discretion. **Released Parties are not responsible for failure of the Event to occur as scheduled for any reason.** Released Parties are not responsible for inability to attend the Event or other inability to use the prize tickets, in which case the prize will be forfeited and no substitution provided. Winner must pick up tickets at Will Call at Broncos Field @ Mile High. No transportation or parking, food or beverages are provided as part of the prize.

By entering this Sweepstakes and accepting the prize, the winner of Post #2 agrees to maintain his/her behavior and the behavior of his/her guest in accordance with all applicable laws and generally accepted social practices in connection with attending the games. The winner understands and agrees that the Sponsors and the owners or operators of the Event venue have the right, in their sole discretion, to disqualify and remove the winner and their guest from any activity at any time if the winner’s or his/her guest’s behavior at any point is uncooperative, disruptive, or may or does cause damage to person, property, or the reputation of Sponsors, or otherwise violates the policies of the Sponsors or the venue operator, and in such a case, the winner will still be solely responsible for all taxes and other expenses related to the prize.

All prize details not specified in these Official Rules will be determined by the Denver Broncos in its sole discretion. EACH ENTRANT AGREES TO RELEASE, HOLD HARMLESS, AND INDEMNIFY EACH OF THE RELEASED PARTIES FROM AND AGAINST ANY LIABILITY WHATSOEVER FOR INJURIES OR DAMAGES OF ANY KIND SUSTAINED IN CONNECTION WITH THE ACCEPTANCE, USE, MISUSE, OR AWARDING OF THE PRIZE OR WHILE PREPARING FOR, PARTICIPATING IN, AND/OR TRAVELING TO OR FROM ANY PRIZE- OR SWEEPSTAKES-RELATED ACTIVITY INCLUDING, WITHOUT LIMITATION, ANY INJURY, DAMAGE, LOSS, DEATH OR ACCIDENT TO OR OF PERSON OR PROPERTY. WINNER AGREES THAT THE PRIZE IS PROVIDED AS-IS WITHOUT ANY WARRANTY, REPRESENTATION, OR GUARANTEE, EXPRESS OR IMPLIED, IN FACT OR IN LAW, WHETHER NOW KNOWN OR HEREINAFTER ENACTED, RELATIVE TO THE USE OR ENJOYMENT OF THE PRIZE, INCLUDING, WITHOUT LIMITATION, ITS QUALITY, MERCHANTABILITY, OR FITNESS FOR A PARTICULAR PURPOSE. EACH WINNER ACKNOWLEDGES THAT HE/SHE IS SOLELY RESPONSIBLE FOR ANY ACTIONS, CLAIMS, OR LIABILITIES OF HIS/HER GUEST RELATED TO ANY SWEEPSTAKES-RELATED ACTIVITY, INCLUDING, WITHOUT LIMITATION, ANY ACTIONS, CLAIMS OR LIABILITIES RELATED TO GUEST'S USE OF THE PRIZE.**

**8. GENERAL RULES.** By entering the Sweepstakes (except where prohibited by law), each entrant grants the Released Parties the irrevocable, sublicensable, absolute right and permission to use, publish, post or display his or her name, likeness, photograph, voice, prize information, biographical information, any quotes attributable to him or her and any other indicia of persona (regardless of whether altered, changed, modified, edited, used alone, or used with other material in the Released Parties' sole discretion) for advertising, trade, promotional and publicity purposes without further obligation or compensation of any kind to him or her, anywhere worldwide, in any medium now known or hereafter discovered or devised (including, without limitation, on the Internet), without any limitation of time, and without notice, review, or approval and each entrant releases all Released Parties from any and all liability related thereto. Nothing contained in these Official Rules obligates any of the Released Parties to make use of any of the rights granted herein and winner waives any right to inspect or approve any such use. Sponsors' decisions will be final in all matters relating to this Sweepstakes, including interpretation of these Official Rules, determination of the winners, and awarding of the prizes. All entrants, as a condition of entry, agree to be bound by these Official Rules and the decisions of Sponsors, which are final. Failure to comply with these Official Rules may result in disqualification from this Sweepstakes. Participants further agree to not damage or cause interruption of the Sweepstakes and/or prevent others from using the Sweepstakes. Sponsors reserve the right to restrict or void entries or participation from any IP address if any suspicious entry and/or participation is detected. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Official Rules will otherwise remain in effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. Sponsors disclaim any liability for damage to any computer system resulting from participation in, or accessing or downloading information in connection with, this Sweepstakes. If a dispute regarding an entry cannot be resolved to Sponsors' satisfaction, in their sole discretion, the entry will be deemed ineligible. By entering, you understand that you are providing your entry to Sponsors and not to Facebook. YOU WAIVE ANY AND ALL OBJECTIONS TO JURISDICTION AND VENUE IN THESE COURTS AND HEREBY SUBMIT TO THE JURISDICTION OF THOSE COURTS.
