“Enter to Win a Little Shop Of Physics (LSOP) Clinic”

Official Rules

NO PURCHASE NECESSARY TO PARTICIPATE OR WIN

SWEEPSTAKES PERIOD: Sweepstakes (“Sweepstakes”) begins at 10:00 a.m. Mountain Time (“MT”) on 9/3/2019 and ends at 11:59 p.m. MT on 1/31/2020 (the “Sweepstakes Period”).

ELIGIBILITY: Sweepstakes is only open to full-time and part-time K-12 school teachers, school staff and school principals who are employed by public or private schools (see School definition below), legal residents of the United States, 18 years of age or older and reside within seventy-five (75) miles of the Denver, CO state capitol (zip code: 80203). The School awarded the Prize must also reside within 75 miles of Denver, CO state capitol (zip code: 80203). The School is defined as a public, or private, Kindergarten through High School (K-12) institution (“School”). Employees of CenturyLink (“Sponsor”), Denver Broncos, and their respective parents, subsidiaries, affiliates, licensees, retailers and promotion and advertising agencies, and members of their immediate family (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and persons living in the same household of such employees, whether or not related, are not eligible to participate. HOW TO ENTER: During the Sweepstakes Period, visit www.DenverBroncos.com/LSOP and follow the directions provided to complete the registration form to receive one (1) entry (each, an “Entry”). All Entries must be received by 11:59 p.m. MT on 1/31/2020 to be considered. Entries generated by script, macro or other automated means and Entries by any means which subvert the entry process are void. Limit one (1) Entry per person using only one (1) e-mail address throughout the Sweepstakes Period. Multiple Entries received from any person or e-mail address in excess of the limitation stated above will be void. On-line entries will be declared made by the authorized account holder of the e-mail address submitted at time of entry. “Authorized account holder” is defined as the natural person who is assigned to an e-mail address by an Internet access provider, online service provider or other organization (e.g., business, educational, institution, etc.) responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. If for any reason the Sponsor is not capable of running the Sweepstakes as planned due to, among other factors, any technical failure or corruptions of any kind, the Sponsor reserves the right to cancel, modify or suspend the Sweepstakes and select winners from eligible entries received prior to cancellation. Per the winning entry, the entrant may be required to provide Sponsor with confirmation that he/she is the authorized account holder of the listed email address (if any). If entry

into the Sweepstakes is made from a wireless mobile device, Sponsor is not responsible for any charges from the wireless phone provider to enter, if applicable.

RANDOM DRAWING: One (1) potential winner/School will be selected in a random drawing held on 2/10/2020 from among all eligible Entries received during the Sweepstakes Period. Odds of winning depend on the number of eligible Entries received during the Sweepstakes Period.

WINNER NOTIFICATION: The Sponsor and Denver Bronco's decisions are final and binding on all matters relating to this Sweepstakes. Potential winner will be notified at the telephone number provided on their registration form on 2/10/2020. If potential winner does not answer his/her phone (or is otherwise unavailable during initial contact attempt), no message will be left and no further attempt to contact such individual will be made and that individual will be disqualified, and an alternate potential winner may be selected via a second random drawing, time permitting and at Sponsor's sole discretion. The School selected as the recipient of the Prize may decline Prize, if preferred, and a second random drawing will be conducted. Potential winner, and the School administrators at Prize-winning School, will be required to execute and return an affidavit of eligibility, a liability release and, where lawful, a publicity release within two (2) days of date of issuance. If such documents are not returned within the specified time period, prize or prize notification is returned as undeliverable, Sponsor is unable to contact potential winner or potential winner/School is not in compliance with these Official Rules, prize will be forfeited, and, at Sponsor's discretion, an alternate winner may be selected via an additional random drawing.

PRIZE (1): The School that the eligible winner deems the recipient of the Prize will receive one visit from Little Shop of Physics at their school. Little Shop of Physics will conduct a clinic for students at the School. Exact date, time, and location of clinic to be determined by Little Shop of Physics and the Denver Broncos in its sole discretion. All prize details are at the sole discretion of the Denver Broncos. Any difference between stated value and actual value will not be awarded. Clinic must be held on dates specified by Sponsor or prize will be forfeited and Sponsor will have no further obligation to winner. All federal, state and local taxes and all other costs associated with prize acceptance and use not specified herein as being provided. Prize is awarded "as is" with no warranty or guarantee, either express or implied. No substitution, transfer, or cash equivalent of prize is permitted, except by Sponsor, which reserves the right to substitute a prize with one of comparable or greater value, at its sole discretion.

FOOTAGE: Individuals arriving at the clinic may be photographed, videotaped and otherwise recorded by the Denver Broncos and Sponsor (collectively, "Footage"). Footage will be owned by the Denver Broncos and Sponsor which have the right to use, edit, adapt, post, stream, copy and exploit such Footage and all elements embodied therein, including any names and likenesses embodied therein, in any and all media now known or hereafter devised throughout the world, in perpetuity, for advertising, promotional, trade and other purposes. By accepting a Prize, Prize winner agrees that his/her name and likeness and those of any other individuals present may be included in the Footage, in the Denver
